SCHOOL DASH FOR CASH FUNDRAISER APPLICATION

The "Dash for Cash" Fundraiser is a commission program similar to See's Candies, wrapping paper, and dine-out fundraisers, but better. At such fundraisers, school supporters purchase from a business, and the business pays the school a percentage (typically 10-20%) of the amount spent, keeping the rest.

With the "Dash for Cash" Fundraiser, Newport Spirit Run pays the school a percentage of registration fees spent by its supporters, but the percentage paid can be much greater than similar fundraisers. The percentage a school earns **begins at 25%**, and **increases to as much as 45%**! Also, the percentage of registration fees a school doesn't receive benefits other schools, youth sports teams, and other youth causes rather than a for-profit business. And, the school will be promoting health and fitness and school spirit.

Below is a chart displaying various registration fee levels, the corresponding percentage commission, and the maximum to be raised at each level. **To receive a commission, a school must register a minimum of 10 students. Students registered with a scholarship are counted as if paid.**

Fees paid by school registrants	School Commission at Level	Maximum Commission at threshold	Cumulative Commission if thresholds met
First \$1000	25%	\$250	\$250
Up to next \$1250	30%	\$375	\$625
Up to next \$2500	35%	\$875	\$1500
Up to next \$4500	38%	\$1710	\$3210
Up to next \$6000	40%	\$2400	\$5610
Up to next \$10000	45%	\$4500	\$10110
